Anyone who knows me, knows that I have a crazy obsession with severe weather. Whether it's a blizzard with 2 feet of snow in December or tornadoes and monsoon rains in April, I get excited with the mere mention of such a possibility. Lightning, hail, high winds, and other severe weather all demand respect and can cause severe damage, which is not good for crops, personal property, and people's ※ wellbeing. Obviously, those points are **not** what I enjoy about severe weather. I think the reason it excites me is because I know how awesome Mother Nature's power is. Now, before you start pointing fingers at me and calling me a "sick person that enjoys seeing peoples' lives ruined," I can assure you that I do not enjoy or wish to see anybody's life affected in a negative way during an adverse weather event. I assume I'm infected with the same thing storm chasers have..... Severe weather is awe inspiring and spectacular to witness, to say the least. I'm sure some of you still think I'm <u>nuts</u>. Hopefully a few of you are nodding your head in agreement.

Whether or not you enjoy (or despise) weather in its more dominant form, it is a reality in the lives of us all in Missouri, <mark>especially in the Spring time!</mark> Weather in Missouri constantly decides to swing chaotically from warm to cold to snow to tornadoes all in a 4 hour period! I have always said "If you don't like our weather, wait an hour and it will change" or so it seems. Sometimes, it's hard to keep track of what is going on out there. Fortunately, we have warning systems in place now and a network of trained weather spotters to help give advance warnings of severe and potentially dangerous weather. It is important to have a plan in place for how to react to potential severe weather and another plan for what to do in the event of a natural disaster, whether it is destruction from a flood or a twister, like the ones that struck Stockton and Joplin. Hopefully, you have a plan of what to do during severe watches, warnings, and in * the aftermath of such an event, whether when you're at home with your family or with your coworkers on the job. If you do not, I would ★ recommend that you come up with plans for your family to help keep them safe during severe weather. Another thing to consider is the <mark>role of your ambulance if your response area experiences a weather event of biblical proportions. Obviously, if there are injuries or other</mark> advanced skills needed by fire and other EMS crews, you will be paged out.

But what about preparedness for such an event? Do you and your partner know what to do and have a plan? Waiting until the disaster * happens to make a plan it too late. Everyone should be looking or inquiring into options now before another Stockton or Joplin occurs in our region. A few items to always keep on hand are water and food (for at least 72 hours), blankets, flashlights, batteries and medications. - o You can go into https://healthems.com and you can set up a password recovery. There is an option for you to set up your own account details as well.
- The medical home department has requested that we make certain to list the patient's primary care physician.
 - The physician field has always been listed as desired/yellow because we know it is not always possible to find out that information.
 - The medical home department gets a report from us every 30 days. That report lists any patient that has been transported twice by any of our ambulances in the last 90 days. The medical home department follows up with those patients making sure they have a primary care physician and are receiving follow up on for their reason for visit. This is very similar to the Community Paramedic program that you may have heard about. The best part of our program is a licensed clinical social worker (LCSW) is doing it. This is saving one of our paramedics for emergency and non-emergency calls instead. The LCSW is very familiar with programs available to our patients and of the several possibilities for them. The end goal is they no longer need our services.
- As we go to more facilities, people contact me to add a facility to HealthEMS. When you call, I need:
 - A HIPPA complaint fax number, preferably the medical records fax number.
 - We want our record to be actually put into the pt's chart.
 - The true name of the facility,
 - o Street address,
 - o Town,
 - o If you can, get the name of the county.
- The two errors I see the most are
 - o Number of patients transported.
 - Please be aware of how the number of patients transported in our vehicle reacts to run dispositions. In the 5 years we have used HealthEMS, there has been a lot of discussion (and confusion) over giving another ambulance your patient. There is a FAQ and a Powerpoint on how to keep from getting a data error.

 - Documenting a transfer /transfer details.
 - I know that most everyone dislikes transfers. It might be everyone EXTREMELY DISLIKES transfers.
 Arguably, the worst thing is getting that chart back to correct.
 - Here are the three things we ABSOLUTELY need in your narrative.
 - 1. First is the reason why they originally came to the Emergency Department.
 - You can find that on the triage nurse's documentation.
 - 2. Second is the Diagnosis that the emergency department physician gave the patient.
 - o You can find that in the doctors documentation.
 - You can also find that in the discharge instructions that are given to us to take to the nursing home.
 - 3. The last thing is the reason they have to ride in the ambulance.

o That might be a simple statement of "There was no other transportation for the patient to use to get back to their destination."

Please remember to be safe and watch out for your partner. -Morg

★ It appears there will be at least one new hire in next month's academy. I will share more information next month.

The instructors for next month's competencies have been working hard to deliver some good education for the department. Cody and Amanda are going to start out with some basics of caring for civilians and law enforcement in high-risk situations. This will also serve as in-service education for hemostatic agents and a refresher on tourniquets. Tammi is going to conclude with the use of TXA and Ketamine on trauma patients. After this competency, we will be good to go to order and place hemostatic gauze and TXA on the ambulances. Ketamine will happen after the respiratory competency in August when we put the rest of RSI on the ambulances. Please plan on this month's competencies to be approximately 4 hours. The dates, times and locations are listed in the Upcoming Events for June section on page 4.

Reminder that on 6/3 at 1300 our corporate lawyer will be in the community rooms to answer specific questions EMS has regarding mental health transfers.

🛪 Last month, we had a review from the state to update our ambulance license. There were only two things of significance we need to work on improving.

- The first area of improvement is driver training.
 - Annually, we need to document that each employee is getting driver's training. Don Stockton is working on a Healthstream to meet that requirement in addition to new hire orientation follow-up paperwork to support new hires getting driver training.
- The second area of improvement is our protocols do not match what is on the ambulance.
 - Mostly, this is our desire to make protocols more fluid and able to handle changes in ordering practices and availability of medications and equipment. Apparently, the state does not agree with this method, so we will be adding a page to the protocols with exactly which medications and equipment are currently being carried on each ambulance. If we add or remove an item, the protocol will have to be updated and signed.

※ Next year, Cedar County's license is up for renewal and we are planning on inspecting all three ambulance licenses as well as the training * license at the same time instead of having different expiration dates like we do now.


