#### From the Desk of the FTO Program Manager:

Field Training and Evaluation Program (FTEP). I'm sure everyone has heard by now the FTO program has gone through quite an overhaul. Indeed, several changes have been made, like the separation of the FTO's and EMS Educators. The first step in any change is education, that said, the FTEP classes begin this coming February, and completion of all FTEP updates by June of this year. This new way to train and evaluate our new hires, students, and exiting staff will be a marked improvement.

New Hire/On-Boarding process. Starting this year CMH-EMS will be implementing a new procedure for all new hires. The will be a systematic 110-day process consisting of an initial ten-day process of adding the new hire into the many systems we use, like HealthEMS and HealthStreams. Over the next 90-days the new hire will have a primary FTO assigned, rotations with their primary FTO, rotations among the different counties we serve, all the while being evaluated on their performance, behavior, and conduct. There are 30-day stops to conduct overall evaluations on the new-hire, and to carefully move them through to release to field duty.

**Competencies**. We are back to four quarterly competencies this year. With the first coming in March, so don't forget to look at the Spring Education schedule for dates and times. (I still need a Polk County Educator for this competency!) There is new criteria for the competencies that involves our EMS Educators and FTO's to share in the delivery of these classes. Remember, if you are a certified EMS Educator, teaching competencies solves two vital functions, CEU's for the topic taught, plus CEU's for your Educator status.

**HealthStreams**: As you know from Theron's past e-mail there is a whole on-line HealthStream education package directed to EMS topics. If you would like to be assigned any classes, please let myself or Theron know. Also, Educators, keep in mind you can use them in conjunction with any Competency topic you with to teach.

If you have ideas or thoughts on system improvements, or classes for development in HealthStream let me know.

## A few SAFETY Tips From Brice

As I write this it is over 60 degrees in the garage with the doors open! Amazing breath of fresh air in the middle of winter. I hope the new year is going well for all of you. I don't have much to say this month, just a reminder. We have talked a lot about monitor safety over the past year. We tested out a TechniMount system a year ago, come February. Some liked it and some didn't. In any case, we need to/must keep our monitors secured in the back of the ambulance. When going to a call either secured in a seatbelt on the cot or in a seat; it is the single most expensive and valuable piece of equipment on the ambulance.

Here is an idea to put in your head. It might help start securing the monitor as the normal part of operations that it ought to be. When loading the patient and preparing for transport you and your partner should hear three clicks in the back of the ambulance.

- The cot clicking into the cot mount
- The monitor being secured with a seatbelt
- You putting on your seatbelt before leaving the scene

Of course the patient should already be secured with all safety straps on the cot before being loaded, and the ambulance operator should be seat belted.

Just a simple reminder to listen for 3 clicks.

Do you remember the 6 rights of drug administration? It helps to have an easy and quick reminder to get us all in on keeping ourselves and the patient safe. Give it a try and remind your partner to make safe choices.
